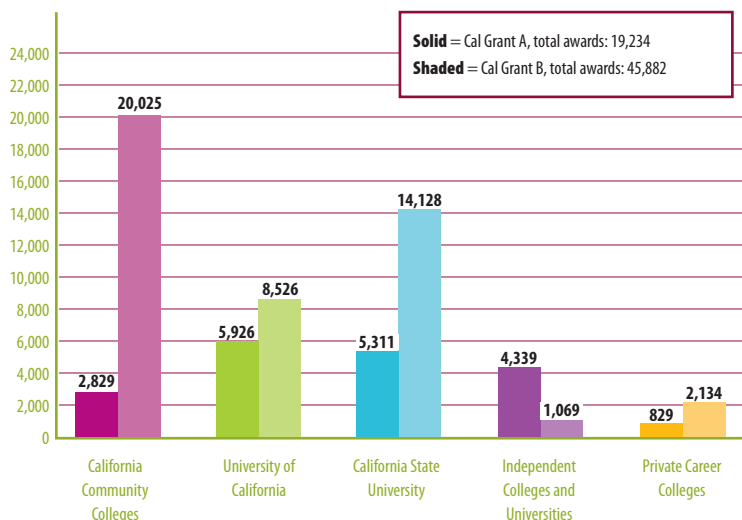
This document displays data about the 2007–08 High School Entitlement Cal Grants awarded to recipients. Total High School Entitlement recipients: 65,116

Senate Bill 1644 (Chapter 403, Statutes of 2000) guaranteed an Entitlement Cal Grant A or B award to every graduating high school senior who has financial need and who is academically eligible. This guarantee moved California closer to making college accessible and affordable for all those who wish to seek a postsecondary education.

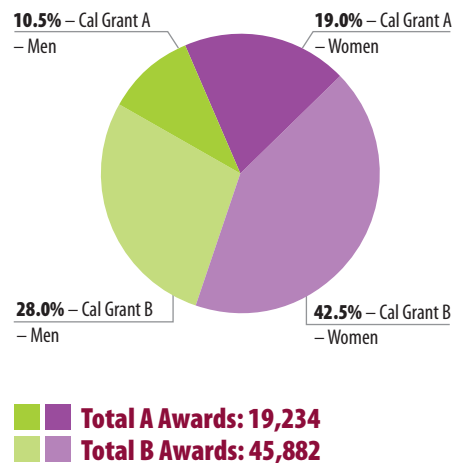
Beginning in 2001–02, the Entitlement provisions were in effect for new Cal Grant applicants who graduated from high school starting July 1, 2000. For the 2007–08 March 2 Entitlement award application deadline, the applicant pool includes recent high school graduates, as well as those who graduated in 2005–06 and did not receive a Cal Grant award.

For the 2007–08 award cycle, the Commission continued to partner with education stakeholders, the California Legislature, the Governor’s Office and the Office of the Secretary for Education, as well as the private sector and community-based organizations, to provide an outreach and public awareness effort that included statewide student and parent workshops, school-based financial aid training, ethnic media coverage and outreach. As a result, Entitlement Cal Grant awards continue to pave the way for California’s diverse students to access a postsecondary education.

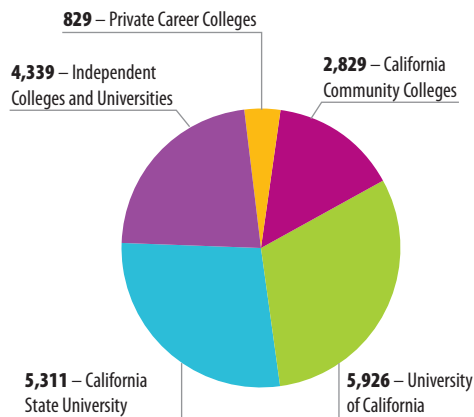
Award requirements include financial and basic eligibility, a minimum 3.0 grade point average (GPA) and graduation from high school in 2005–06 or 2006–07. Cal Grant A awards provide for full systemwide fees at the California State University and the University of California, as well as tuition support at independent California colleges and universities and private career colleges. Of these Cal Grant A awards, 18,124 were awarded to 2006–07 high school graduates, while 6 percent, or 1,110, were awarded to those who graduated in 2005–06.

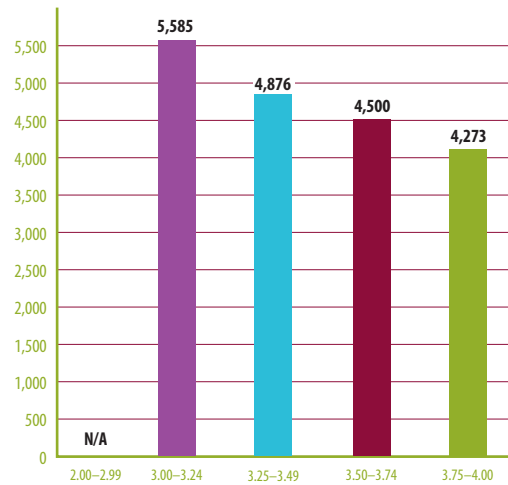

Cal Grant A Awards by School Segment

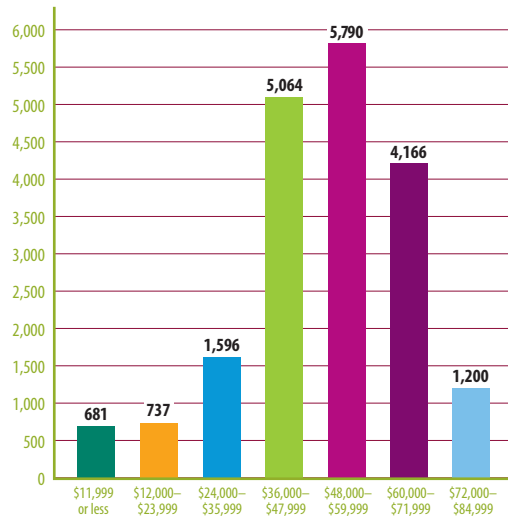

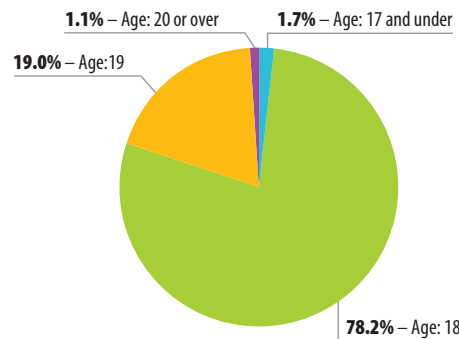
Cal Grant A Awards by GPA



Cal Grant A Awards by Income

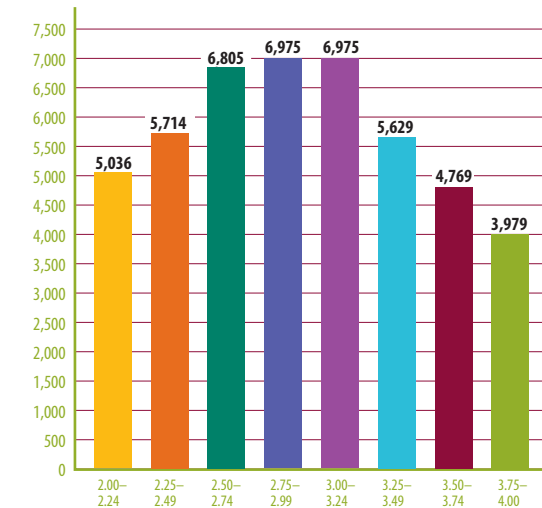


Cal Grant A Awards by Age

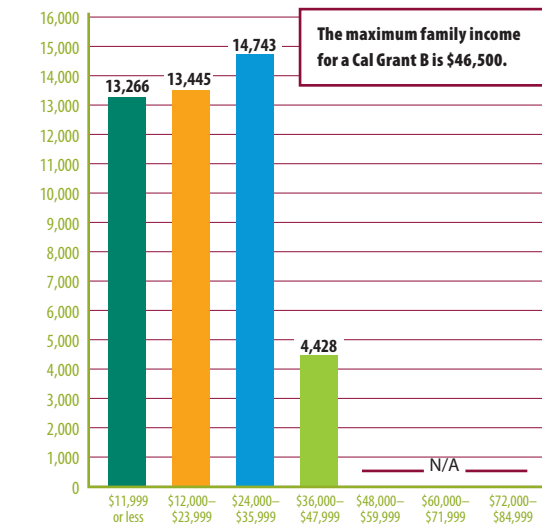


Entitlement Cal Grant

B

Award requirements include financial and basic eligibility, a minimum 2.0 GPA and graduation from high school in 2005–06 or 2006–07. Cal Grant B awards provide up to \$1,551 for books and living expenses for first-year students. Beginning with the recipient’s second year of attendance, Cal Grant B awards also help pay for tuition and fees at public and independent four-year colleges or other qualifying institutions. Of these Cal Grant B awards, 43,475 were awarded to 2006–07 high school graduates, while 5 percent, or 2,407, were awarded to those who graduated in 2005–06.

Cal Grant B Awards by Income

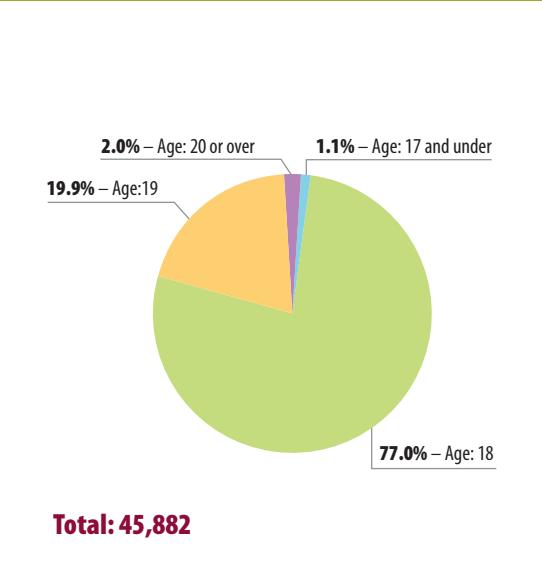


Average Parental Assets by Segment*

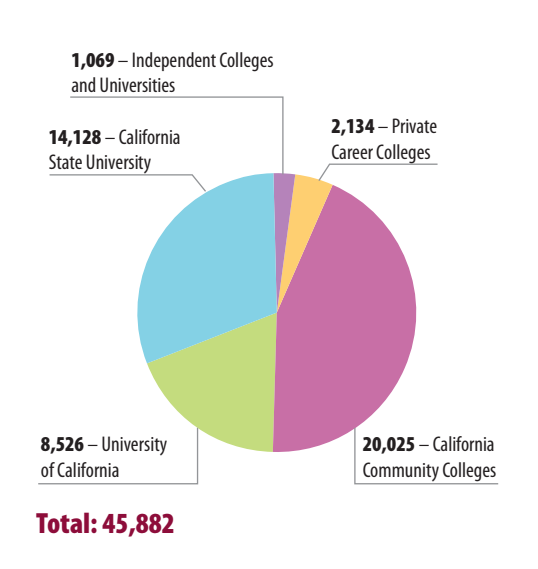

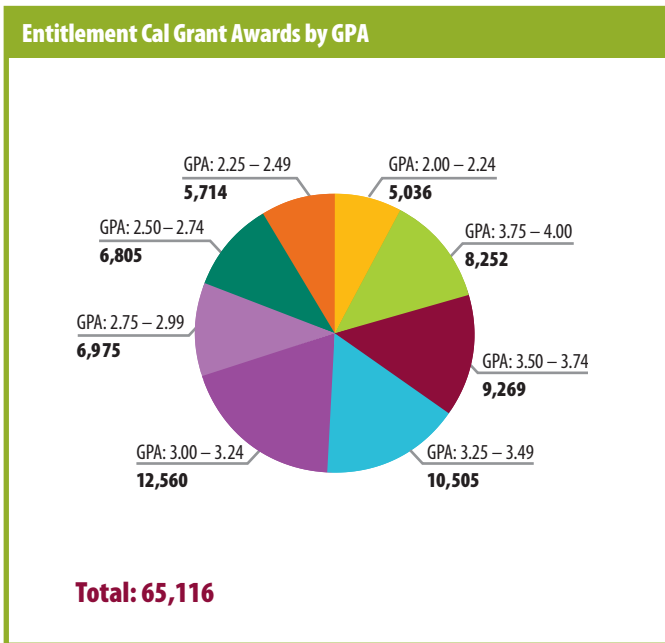
Cal Grant B Awards by Age

About the Recipients



About the Applicants

Applicants must meet multiple criteria to qualify.

Submitting both the Free Application for Federal Student Aid (FAFSA) and the Cal Grant GPA Verification Form is the first step for students to be considered for an Entitlement award. Of the 136,172 students who were successful in completing this first step, 27,097 did not qualify for various reasons. Examples of these reasons include: not listing a qualifying California school on the FAFSA, neglecting to indicate they were a California resident at the time of high school graduation, and mistakenly indicating they had already graduated with a bachelor’s degree. These applicants were given the opportunity to correct their application and receive an Entitlement award. The remaining 109,075 applicants were matched against the program’s financial criteria, with 65,116 meeting the ceilings.
